To best prepare these hopeful coaches the advising body for the Coaching Cert decided it would be in the best interest of students taking classes and the certificate itself if the number of units in the certificated program was reduced from 12 to 6. The classes necessary to complete will need to be changed to HEED 204 and KINE 202.




General Enrollment (Insert Aggregated Data Chart)







The graph generated by checking the appropriate boxes in the link does not provide a side-byside comparison of successful course completion for KINE 213 KINE 202 alongside the college. What can be determined from the bar graph is that the courses listed above have an extremely high course completion rate in both the online modality and the face-to-face modality.

Degrees and Certificates Awarded (Insert Data Chart)

The drop-down menu for degrees and certificates awarded under the umbrella of Kinesiology did not provide the Coaching Certificate as an option to pick from. Therefore, the graph above does not provide the data needed to successfully demonstrate awards.

General Student Success - Course Completion (Insert Aggregated Data Chart)

From 2014-2015 through 2019-2020 the successful course completion rate for HEED 204 and KINE 202 has been significantly higher then the college success rate during that time. Overall, Cuesta College saw its highest completion rates in the 2019-2020 year at 82.49%. During that same time period HEED 204 and KINE 202 saw their highest course completion rates at 92.86%. Between the years of 2015-2016 and 2018-2019 the college and HEED/KINE successful course completion rates ebbed and flowed. HEED/KINE reaching up to 89.55% completion in 2015-2016 and no lower then 79.35% in 2018-2019. The college has stayed consistent at 74-75% during this same time period.

The bar graph displayed above corroborates what would be expected of fill rates for low-income individuals and non-low income individuals taking either HEED 204 or KINE 202. The success rate is significantly lower for low income individuals at 68.64%. The performance gap signals a 12.20% lower performance for low-income individuals and a 9.81 higher success rate for non-low income individuals.

Other Relevant Program Data (optional)

As a result of Student Learning Outcomes Assessments, the Coaching Certificate housed in the Kinesiology department has gone through a major overhaul. Has been determined that the overall number of units required to receive a Coaching Certificate should be reduced. CIF certified coaches must only take a Principle of Coaching course and be CPR/First Aid certified to be certified to coaching at California Interscholastic Federation institutions. In order to cater to the needs of probable CIF coaches the Coaching Certificate has been reduced from 12 units to 6 units. The six units required to complete the Coaching Certificate are KINE 202, Principles of

Coaching and HEED 204, CPR/First Aid as dictated by CIF. These courses are also offered on-line and hybrid (HEED 204 has a lab component) and can be completed within an 8-week summer session. The hope of the department is to increase the number of completed Coaching Certificates through the process of change listed above.
